- Note 1:** Correct Lengths of all boats must be given at time of booking from Pulpit to Davit Arms or Platforms, these will be checked by Club Staff.
- Note 2:** Members storing, berthing and mooring boats and trailers do so at their own risk.
NBYC cannot be held responsible for any damage done to Member's boats.
- Note 3:** Members bringing additional boats for use at any time of the year must notify the Office for allocation of buoys and moorings. Additional fees are payable.
- Note 4:** All boats remaining on Club premises after 1st December 2019 will be charged pro rata at the appropriate fees until removed, unless winter storage has been applied for.
- Note 5:** Members requiring winter storage must complete a separate application and send to the Office with the appropriate fees.
- Note 6:** All craft kept at the Club (including all launching trolleys and road trailers) MUST be marked with the owner's name for identification purposes.
- Note 7:** It is the owner's responsibility to inform the Office of meter readings at the point of mooring up and departing your pen.
